Representative example:

For a repayment mortgage of £148,618 over a 29 year term, you will make 24 monthly repayments of £836.06 at 5.29% fixed until 30 June 2026. This will be followed by a further: 324 monthly repayments of £1,159.61 a month at the Homeowner Variable Rate, currently 8.74% for the remainder of the term. The total amount payable would be £395,779.08, made up of the loan amount plus interest (£247,161.08).

The overall cost for comparison is 8.4% APRC Representative.

Your first monthly payment will be higher as it includes interest from the date the funds are released as well as the monthly repayment.
